

## Wang On Group's Allmart Markets Distribute Free Rice To Promote Yu Lan Festival's Spirit of Giving

(8 August 2019 – Hong Kong) Free rice will be distributed at Allmart markets under Wang On Group Limited (“Wang On Group”, stock code: 1222) from 5 to 9 August 2019 before the Yu Lan Festival (the Hungry Ghost Festival).
